### **Application scope**

### **Policy**

AMG Brasil's Privacy Policy is a document published on its website that informs visitors about its applicability, responsibilities, what information is collected, its commitment to complying with privacy protection legislation, and who to contact in case of questions.

### **Responsibilities**

**Data Protection Officer/DPO:** is the person responsible for this policy, ensuring that it is up to date. The Data Protection Officer/DPO, with the support of AMG Brasil's Data Protection Committee, should clarify doubts about this Policy and the processing of personal data of individuals who have business activity contracts with AMG Brasil, accept complaints and communications from data subjects, provide clarifications and take action.

### **Cookies**

AMG Brasil's website uses cookies, which are small files placed on your machine to help the site providing a better user experience. In general, cookies are used to maintain user preferences and store information related to the user's connection.

As a rule, cookies will make your browsing experience better. However, you may prefer to disable cookies on AMG Brasil's website and on others. The most effective way to do this is to disable cookies in your browser. By disabling cookies on AMG Brasil's website, some features may not be available.

AMG Brasil may monitor visitor activity to its website using IP addresses and setting temporary cookies to monitor user sessions. The data collected helps record the number of visitors. No personal information is collected from users in these cookies.

### **Personal data**

The collection of personal data by AMG Brasil is done to formalize employment contracts, supply contracts, service provision, among other types related to its business activities, being stored to fulfill its legal and/or contractual obligations, however this collection is not done through the Company's website. Personal data is not collected through the AMG Brasil website, only from the email in the Compliance form (at the path: <https://amg-br.com/pt/contato/compliance/>) if the user wants to inform it, as it is an optional field and in the AMG contact form (at the following link: <https://amg-br.com/pt/relacionamento-com-a-comunidade/>), if the data subject gives their consent for the sharing of information with AMG.
